# Byrne State Crisis Intervention Program

In June 2022, the federal Bipartisan Safer Communities Act was enacted, establishing new provisions and funding streams focused on addressing gun violence and improving responses to behavioral health crises.

The Byrne State Crisis Intervention Program (SCIP) is administered by the U.S. Department of Justice's Bureau of Justice Assistance (DOJ/BJA) and provides formula-based funds to states to implement state crisis intervention court proceedings and related programs + initiatives.

PCCD is responsible for administering federal SCIP funds and undertook a comprehensive strategic planning process to identify priorities for use of Pennsylvania's FY22-23 Byrne SCIP allocation.



# PA's Byrne SCIP FY22-23 Funding Plan

PA's inaugural [SCIP Funding Plan](#) provides a roadmap for how PCCD will invest approximately \$8.5 million in federal funds.

- ✓ **Objective 3.1:** Evaluate current implementation of Act 79 of 2018, a law requiring relinquishment of guns and other weapons by domestic abusers, by local jurisdictions and identify strategies to improve implementation.

The goal of this solicitation is to evaluate current implementation of Act 79 of 2018 by local jurisdictions in Pennsylvania and identify strategies to improve implementation.

# What is Act 79 of 2018?

[Act 79 of 2018](#) went into effect on April 10, 2019, and marked a significant watershed moment for increasing protections for domestic violence victims/survivors in Pennsylvania.

This landmark bipartisan legislation established new requirements and procedures for firearm relinquishment in cases of Protection From Abuse (PFA) orders and convictions of misdemeanor crimes of domestic violence within 24 hours.

The law spurred a dramatic shift in practices for courts, victim advocates, and state and local law enforcement impacted by the law's provisions and responsible for carrying out its implementation in local jurisdictions.

# Building on Previous Research

- More than 60,000 weapons relinquishment orders were granted between May 2019 and January 2023.
- Approximately 35% of PFA cases during this period resulted in a final weapons relinquishment order (13,504 cases).
- Successful retrieval of weapons occurred 85% of the time, with more than 90% being retrieved on the same day or before.
- Sheriffs' departments are largely responsible for weapons relinquishments, performing over 75% of retrievals across the Commonwealth.

### Main Findings

Information on the prevalence and scope of Protection from Abuse (PFA) petitions, orders, and cases is difficult to find and typically lacks important details, especially when such orders require the relinquishment of firearms from the alleged perpetrator. Using a rich dataset from the Pennsylvania Protection From Abuse Database (PFAD), researchers from PCCD/IUP performed a statistical analysis of PFA orders and cases from May 2019 to January 2023, finding the following:

- **Overall Orders and Cases:** Pennsylvania courts conducted PFA hearings for over 105,000 unique cases – 67,670 cases that consisted only of temporary orders (either ending in agreement or not being granted a final order) and 38,107 cases that ended with a granted order after a final hearing. As many cases include multiple orders (i.e., temporary and final), more than 200,000 orders were granted over this timeframe.
- **Weapons Relinquishment Orders:** 13,504 unique cases ended with a final weapons relinquishment order (35% of cases). Again, many cases may contain both temporary and final orders for



# Eligible Applicants

Entities with experience, expertise, and credibility to conduct key project deliverables associated with this funding announcement.

- Institutions of higher education
- Nonprofit organizations
- Research agencies/institutions (including for-profit organizations)



# Eligible & Ineligible Activities and Expenses

## Eligible:

Funds for the proposed program shall be used to implement project-related activities aligned with the project's goals, objectives, and key deliverables.

- Funds may only be used to pay for expenses directly related to the activities, management, and coordination of the project.
- Administrative costs are allowable; however, applicants are strongly encouraged to only budget for costs necessary for project implementation.

## Ineligible:

- Prizes, rewards, entertainment, trinkets (or any type of monetary incentive)
- Client stipends
- Gift cards
- Food and Beverage
- Lobbying
- Land Acquisition
- Unmanned aircraft systems (UAS), including unmanned aircraft vehicles (UAV), and all accompanying accessories to support UAS or UAV
- Any unallowable costs listed in the [DOJ Grants Financial Guide](#).

# Key Objectives

## Objective 1

Conduct a comprehensive qualitative analysis of a subset of Pennsylvania counties' implementation of Act 79 of 2018 to provide context for findings from quantitative analysis previously conducted by PCCD/IUP, including determining local procedures for data collection and input.



# Key Objectives

## Objective 2

Assess community-level implementation of Act 79 through five critical lenses:

1. Victims seeking assistance from law enforcement and engaging in the PFA process in cases involving domestic violence with firearms
2. Law enforcement officers responsible for responding to cases of domestic violence where firearms are involved
3. Victim witnesses and victim services agencies helping clients navigating the PFA process while balancing safety considerations
4. Judges responsible for implementing Act 79's weapons relinquishment provisions within Pennsylvania's courtrooms
5. Sheriffs' offices and law enforcement agencies responsible for retrieval of weapons ordered to be relinquished as part of the PFA process



# Key Objectives

## Objective 3

Examine the effects of Act 79's weapons relinquishment requirements on victims' perceptions of safety and efficacy within the PFA process, including their willingness to seek protection, assistance, and intervention from the criminal justice system.

## Objective 4

Recommend strategies for policy and practice changes at the state and local levels based on these findings and in consultation with key stakeholders most impacted by Act 79's provisions.



# Research Questions



PCCD has outlined seven (7) questions which will help explore the implementation of Act 79 across Pennsylvania counties. These questions can be found in the [funding announcement](#) on the PCCD website.

Applicants should provide a detailed plan for their proposed qualitative research methods and activities designed to address these key research questions within their application.



# Key Deliverables

1

Development and delivery of interim study reports with any preliminary findings.

2

Development and delivery of a final research report by the end of the project period, which includes a summary of key findings + recommendations.

Application (Egrants)

Application Review and Scoring

## Phase 3:

Advisory Committee and Commission Approval

## Phase 4:

Federal Approval (BJA)

## Phase 5:

Project Implementation



# Application Process

- Eligible organizations must submit applications using PCCD's Egrants System.
- Final recommendation of projects will be made following the receipt and review of applications in Egrants.



**Applications must be submitted electronically in PCCD's Egrants System by 11:59 p.m. on July 9, 2024.**

# Getting Started in Egrants


**Step 1:** Create an Egrants account (see [Getting Started in Egrants](#) webpage + the [PCCD Egrants Keystone Login Guide](#)).

**Step 2:** [Register](#) your organization with Egrants.

**Step 3:** Request roles in Egrants (see [Appendix A](#)) to make sure you have the right users and permissions set up.



# Agency Registration



Complete the [Egrants Agency Registration Request Form](#)

PCCD Home Page → Egrants icon.

Your agency must be properly registered in Egrants if you intend to apply for a grant.

\*Authorized Officials are persons with contract signing authority; generally, the Executive Director or Head Administrator of the Agency.

# User Roles

Access to the Agency's grants are separated into six unique roles:

- **Financial Creator** can ***view and create*** fiscal information (manage budget section information, fiscal reports, etc.)
- **Financial Reader** can ***view*** fiscal information
- **Program Creator** can ***view and create*** program information (manage program section information, program reports, etc.)
- **Program Reader** can ***view*** program information
- **Submission** can ***submit*** grant forms like applications, modification, and continuations
- **User Manager** can ***manage user roles*** for the Agency's grants (*will still need other roles if performing other duties*)



# User Registration Tip



Every agency must register **two users** in order to complete their grant application.

# User Manager

Every agency should have an **Agency User Manager** security role.

- The User Manager approves role requests and maintains existing security for users already established within their agency.

- ✓ Statement of Problem (10 points)
- ✓ Project Design & Implementation (35 points)
- ✓ Anticipated Project Outcomes & Impact (15 points)
- ✓ Capabilities & Competencies (25 points)
- ✓ Budget Detail (15 points)
- ✓ Required Attachments



**NOTE:** Applicants are **strongly** encouraged to carefully read and review the written funding announcement document prior to starting their Egrants application.

# PCCD's Funding Process

PCCD grants are reimbursement based (i.e., money isn't provided "up front" for project expenses).

Grantees can only receive reimbursement funding for actual expenses approved by PCCD and DOJ/BJA.

In general, grant funds are designed to support project and program-related expenses, not general operating costs.

PCCD funding must supplement, not supplant existing funding sources/programs.
