### The SPEP and Performance Improvement

The intended use of the SPEP is to optimize the effectiveness of reducing recidivism among juvenile offenders. Recommendations for performance improvement are included in the service feedback report, and these recommendations are the focus of the performance improvement plan, a shared responsibility of the service provider and the local juvenile court. The recommendations for this service included in the feedback report are:

The Adelphoi Village General Secure Care Programs' service of Aggression Replacement Training (ART) scored a 95% Program Optimization Percentage. This intervention was categorized as a Group 5 service; Cognitive-Behavioral Therapy with no qualifying supplemental service. The quality of the service was found to being delivered at a High level. The risk levels of youth participating in this program are: 0% as Low Risk; 100% as Moderate Risk or above; and 28% as High Risk. The amount of service provided to the clients was at 100% of the recommended targeted weeks of duration and 100% of the recommended target contact hours for this service type.

The Adelphoi Village General Secure Care Programs could improve their capacity for recidivism reduction through:

- 1. Identifying an operational strategy to facilitate Anger Control Groups in a closed group format as recommended by Educational Training Alternatives, ETA.
- 2. Acquiring more Train-the-Trainers within the Agency in order to ensure high fidelity of service delivery.
- 3. Improving communication with Allegheny County Juvenile Court and other courts that use this service on the research amount of service that should be provided for this service type.
- 4. Utilizing assessments (i.e. Skill Streaming Checklist, AQ, and How I Think) to determine which components of ART can most benefit youth that receive the service as recommended by Educational Training Alternatives, ETA.
- 5. More consistent utilization of pre and post tests to measure ART outcomes for the agency as recommended by Educational Training Alternatives, ETA.

Aggression Replacement Training® (ART®) consists of a 10-week, 30-hour intervention administered to groups of 8 to 12 juvenile offenders thrice weekly. During these 10 weeks, participating youth typically attend three 1-hour sessions per week, one session each of Skillstreaming, Anger Control Training, and training in Moral Reasoning. The program relies on repetitive learning techniques to teach participants to control impulsiveness and anger, resulting in using more appropriate behaviors. In addition, guided group discussion is used to correct antisocial thinking.

These scores show a decrease of 2 percentage points from baseline findings of the initial SPEP <sup>TM</sup> assessment. Due to the high quality of service delivery, found in both SPEP <sup>TM</sup> assessments, re are no identified recommendations for performance improvement.

#### **Description of Service:**

Headquartered in Latrobe, PA, Adelphoi has programs in over 30 counties, including residential group homes, foster and adoptive care, education services, and in-home treatment options. Adelphoi serves 1200 children, youth, and families each day. Each residential program is designed to meet the individualized needs of youth in placement. As treatment needs change, a unique continuum of care model allows youth to move from one program to another in a way that will ensure success. Education is provided on-site or through Adelphoi's Ketterer Charter School. Adelphoi encourages participation by the family in the youth's treatment and offers family visitation assistance.

Adelphoi provides various types and levels of residential treatment programs for male and female youth across Pennsylvania. Types of treatment include: shelter, diagnostic, specialized independent living, intensive supervision, intensive supervision with a mental health focus, substance use, sex offender treatment, enhanced supervision, and secure care. Treatment is individualized and designed to address a number of criminogenic risk factors, including anger and aggression issues, poor problem solving, mild to moderate mental health issues, strained family dynamics, and trauma. Adelphoi's philosophy is the cycle of degeneration can be altered in favor of positive growth and success through application of the beliefs and principles of brotherly concern coupled with proven treatment modalities.

Secure Facilities provide locked, secure supervision to adjudicated delinquent male and female youth who have committed serious or chronic offenses, are aggressive runaway risks, or display other serious delinquent behaviors. Youth committed to this program have usually had prior contact with the court system and may have had several prior placements. Step-down into a less secure placement is available as the youth progresses. Adelphoi also offers Secure Care for high risk youth who have been adjudicated for sexually victimizing behavior, have a founded abuse allegation or self-admission of an offense.

Youth are placed by the courts within one of Adelphoi's General Secure Care Programs at varied stages of court involvement. This may be the initial out-of-home placement for a youth or may be upon the court transitioning a youth already in placement, within a more restrictive/secure level of care, to a less restrictive level of care. The average length of stay for a youth within one of Adelphoi's General Secure Care Programs falls within the 5- to 6-month range.

Aggression Replacement Training® (ART®) is an evidence-based curriculum proven to help juveniles reduce aggressive behavior and develop pro-social and moral reasoning skills. ART® is a multimodal psycho-educational intervention designed to alter the behavior of chronically aggressive adolescents and young children. The program incorporates three specific interventions: Skillstreaming, Anger Control Training, and Moral Reasoning Training.

- · Skillstreaming uses modeling, role-playing, performance feedback, and transfer training to teach pro-social skills.
- Anger Control Training requires participating youth to bring one or more descriptions of recent anger-arousing experiences (hassles) to each session. Over the duration of the program, youth are trained in how to respond to their hassles.
- Moral Reasoning Training is designed to enhance youths' sense of fairness and justice regarding the needs and rights of others. It is also designed to train youth to imagine the perspectives of others when they confront various moral problem situations.

ART® consists of a 10-week, 30-hour intervention administered to groups of 8 to 12 youth three times weekly. During these 10 weeks, participating youth typically attend three 1-hour sessions per week, one session each of Skillstreaming, Anger Control Training, and Moral Reasoning Training. The program relies on repetitive learning techniques to teach participants to control impulsiveness and anger, resulting in using more appropriate behaviors. In addition, guided group discussion is used to correct antisocial thinking. Differences exist regarding the targeted duration (i.e., weeks) and contact hours for the delivery of ART® in a residential program versus delivery of ART® in a community-based program.

The POP Scores represent a decrease of 2 percentage point(s) from the previous SPEP <sup>TM</sup> Reassessment and a decrease of 4 percentage point(s) from the initial SPEP <sup>TM</sup> Assessment.							
The service was classified as a Group 5 service; Cognitive-behavioral Therapy Service Type. There is no qualifying supplemental service found in the research. The Quality of Service was found to be at a High Level. For Amount of Service, 98% of the youth received the recommended targeted weeks of duration and 98% of the youth received the recommended targeted contact hours for this service type. The Risk Levels of Youth admitted to the service were: 17% low risk, 40% moderate risk, 18% high risk, and 2% very high risk.
