
PUBLIC SAFETY, PUBLIC HEALTH, COMMUNITY PARTNERSHIPS

• Why?

- Systems face shared challenges
- Cross-system collaboration is rare
- Community needs often relevant for both health and safety
- Environmental, social, and political factors perpetuating poor safety outcomes also contribute to poor health
- Challenges
 - Speak different 'languages'
 - Track different outcomes
 - Operate in silos



- Continuous improvement






IMPLEMENTING A VIOLENCE REDUCTION COUNCIL




Lead Agency

generated in case reviews




Working Group

Review Teams

Multidisciplinary teams that review a series of individuals deaths/cases to identify system-level missed opportunities for prevention and intervention



Subcommittees

Focuses attention on recommendations or needs such as case selection




Does it work?



NIJ EVALUATION

- Blue = Intervention Districts
- Grey = Control Districts
- Intervention Districts
 - 52% decrease (statistically significant) in the monthly count of homicide
- Control Districts
 - 9.2% decrease in homicide, (non significant) controlling for the other covariates.
- CrimeSolutions.org
 - The homicide review model is cited as "effective," the highest rating, by both CrimeSolutions



Participants credited the implementation of the recommendations with improving both criminal justice and community provider capacity to prevent violence. Akey to this increased capacity was the improved communication, information sharing and cooperation both within and between criminal justice agencies, community service providers and community members."
